As of March 31, 2020 all TDSB schools are closed until May 4, 2020 by order of the Ontario government to help stop the spread of the Covid-19 virus. 2020 ETFO Annual Meeting Delegates - Candidates Required

Your local is allotted 18 delegates for the 2020 ETFO Annual Meeting. At this time it is looking for two additional members to fill its allotment. The local will also require additional members to serve as alternates. All members who email their interest in being part of the delegation by May 1,2020 will be considered. Below is a bit of information about the ETFO Annual Meeting.

All locals affiliated with ETFO send voting delegates to the Annual Meeting. Delegates discuss and vote on the priorities of the organization, approve the ETFO budget and fees, amend the ETFO Constitution, and fulfill a variety of responsibilities necessary to the operation of ETFO. Accommodation at the Sheraton Centre Hotel and a meal allowance for all members of the delegation is covered by your local for the Annual Meeting.

Motions to Amend the Local's Constitution

In accordance with the Constitution, proposed amendments to the local's Constitution must be submitted to the local office in writing or by email no less than thirty (30) days prior to the Annual Meeting. The local's Annual Meeting is on **May 21, 2020** at the Westin Harbour Castle hotel. **The deadline to submit motions to amend the local's constitution is April 21, 2020 at 4 pm.** If you wish to email your proposed amendments, please email **localdocs@ica.net**. All proposed constitutional amendments shall be posted on the local's website, **www.etfo-torots.org**, at least 14 days prior to the Annual Meeting. Amendments to the Constitution may be made at the Annual Meeting by the affirmative vote of at least 60% of the members present. ETFO Tentative Central Agreement Telephone Town Hall Meetings

All town hall meetings are up to 90 minutes in length. Members may participate in the town hall scheduled for their local. Members can participate in their town hall meeting by phone or through online (on their laptops, mobile devices, etc.) audio live stream. Members will receive a telephone call inviting them to participate in their town hall meeting about 10-20 minutes before the start of the meeting. ETFO Tentative Central Agreement Highlights

Please refer to the ETFO 2019-2022 Teacher/Occasional Teacher Tentative Central Agreement documents for detailed, definitive information on negotiated terms. Members will be emailed a Collective Bargaining E-Newsletter with all ETFO 2019-2022 Teacher/Occasional Teacher Tentative Central Agreement documents on **Monday, April 6, 2020**.

Compensation Increases apply to current LTO salary grids and the daily OT rate as follows:

September 1, 2019 –1.0% increase (retroactive)

September 1, 2020 –1.0% increase

September 1, 2021 – 1.0% increase

Agreement between ETFO and government allows ETFO to continue with its Charter Challenge against wage restraint legislation (Bill 124).

Investment in The Supports for Students Fund in the amount of \$44,337,993 in 2020- 2021 and \$44,781,373 in 2021-2022 will create approximately 434.5 ETFO teacher positions. The positions will address: Special education, English Language Learner, Indigenous student, Early Years special education and Mental health and well-being supports.

The Government has made a binding, enforceable commitment in writing to maintain the current Kindergarten model (with one teacher and one Designated Early Childhood Educator.

A commitment by the government to maintain current class sizes for the life of the collective agreement.

Benefits funding to be increased to reflect:

4% funding –September 1, 2019

4% funding –September 1, 2020

4% funding –September 1, 2021

An additional one-time lump sum payment of up to a maximum of 3% of annual employer FTE, if the net assets of the benefits plan demonstrate need.

Sick Leave entitlements remain status quo for the life of the collective agreement.

Occasional teacher hiring practices in Regulation 274 remain in force and the Ministry Initiatives Committee, which includes representation from ETFO, will be maintained.

Continuation of the Provincial Working Group on Health and Safety.


