# 7) **Timed Item**: **Treasurer's Report** – Jeremy Bass

- ETFO Toronto Local currently has two GIC investments:
  - i) 300K cashable GIC investment at 4.2% with Royal Bank of Canada, and,
  - ii) 45K Fixed rate credit card GIC approx 3.6-3.7%;

While 400K sits in the bank.

- No change in financial reports since Oct. 11, 2024
- Currently transitioning to a paperless system; online banking to be implemented ASAP to reduce mistakes, prevent improper behaviour, and decrease the risk of centralization.
- Treasurer proposes using two financial institutions, namely, RBC and BMO, for diversification.
- President Galippi, per provincial advisory, discourages the usage of multiple financial institutions; ensures that RBC express is consistent with ETFO's digital financial system.
- Treasurer subsequently withdrew proposal for multiple financial institutions
- RBC client cards do not meet our letter of direction that says that at least two signing officers must provide signatures and therefore we now will not be issued client cards.
- While ETFO TO Local deficit remains, 57% of the budget is devoted to released officers salaries.
- An estimated 84K is incoming as part of ETFO provincial's fee rebate.
- Treasurer advises that either reduction of expenses or increase of revenues is required to balance the budget.
- Pie chart revenues, deficit and budget to be presented in November.
- Committees to be trained in budget management in early November.

## 8) **Timed Item**: **President's Report** – Marisa Gallippi

- Nov 5 & 11 proposed by ETFO Toronto Local to TDSB as EOTCC meeting dates.
- Nov 20: talking tour presentation date with ETFO Provincial President Karen Brown, with a focus on provincial political voting. Dependent care, mileage and food (meals provided at event) will be accommodated by provincial for this event. Google survey is up on the website, constant contact has been delivered.
- Local physical office location to be evacuated Oct. 31. New storage unit secured for 6 months. New postal box secured. President, First VP and, as a backup, Treasurer, exclusively hold the PO Box keys.
- The released officers have been assigned and are actively using new email addresses.
- Bi-election nomination notice given in newsletter; B'Dacy to chair the bi-election.
- Targeted contract aka Letter of Engagement was last signed in Feb. 2023.
  Executive will receive the current one for review. Treasurer and President agree that both of them are required to sign the Letter of Engagement.
- Subsequent to the Treasurer's report expressing resistance to online program RBC express, President Galippi reminds The Executive that RBC express had already been implemented by the President and First Vice President.

- Auditor's contract extension to Oct. 31 approved by provincial. The executive declined to review the audit as offered by the president.
- President Gallippi appointed VP Kroesen as parliamentarian for Nov. 12 GM.

# 9) Leadership Conference: New Members Committee Report - James

- History of ETFO info event proposal
- Have a free social event wherein interest for future events is requested
- Low budget meeting solutions can meet with other locals for combined events with combined budgets. Examples include wine and cheese events, valentines events, supermarket cookings, sip n chats, draws for prizes, games night, ETFO presenters
- Swag, freebies, calendars
- Bring a teacher friend incentive welcome
- List from the board of new hirees will be helpful to execute these opportunities
- Every new member can have a free social event per year
- Members can be encouraged to donate food to a food bank upon event entry.
- Welcome letter can include local info and President contact
- Provincial New Members committee suggests free podcasts, etc
- Share and reference kit

# 10) Leadership Conference: Political Action Report - Sotiropoulos

- Maintain positive public rapport and networking including with provincial
- Member votes, but also member engagement and volunteering, are desired.
- Public campaigns, such as the BBS aka Building Better Schools via www.buildingbetterschools.ca campaign
- Creativity to encourage and sustain member commitment as a goal.
- Socials appeal to member engagement.
- Attendance to public parades, picnics, with swag, freebies, refreshments/snacks, bubbles/balloons for children, etc. draws members and parents/adults in.
- Remain communication and response focused to sustain executive accessibility.
- Remembering that P.A isn't just for the elections but in between them as well.
- Overall goal to be seen, to increase engagement and to build member trust.
- When educating and/or discussing with members or media, focus on party platforms rather than on party leaders in order to prevent isolating or excluding members.
- Take an 'every vote counts' approach; resist voter suppression.
- Educators have a powerful role to play in elections because students are listening to them.

- 2SLGBTQIA+ inclusion in the classroom including parent communication, opting out and other issues
- The difficulty of engaging members amidst a limited budget; considering funding opportunities, pairing with communities and charities

# 14) Leadership Conference: Early Reading Screen Report - Chintakunta

- Mental health and the representation of relevant cases that occur in ETFO was discussed
- 98% member claims are not approved, though ETFO still recognizes that members whose mental health has been affected and supports should be in place
- By mid-Oct, all elementary reading assessments are expected to be completed
- Classroom sizes and overall disorganization is observed;
- Staffing is arranged via extra staff provided to provide teachers the time opportunity to accomplish reading assessments on time.
